Among his many duties as a U.S. Marshal, Hughes is responsible for leading fugitive task forces, operating the Witness Security Program, and seizing property acquired by criminals through illegal activities. Prior to his appointment in 2002, Hughes was Director of High Intensity Drug Trafficking Area Information Office. He also worked for the Maryland State Police from 1967 to 1996. He was awarded the United States Attorney General's Special Commendation Award in 1993 and National Law Enforcement Council Achievement Award in 1992.
